Development Objective Cooperation Agreement between the Republic of Armenia and the United States of America for More Participatory, Effective and Accountable Governance

AMENDMENT NUMBER SIX to the Development Objective Cooperation Agreement between the Republic of Armenia, acting through the Office of the Head of the Government Staff (hereinafter referred to as the "Grantee") and the United States of America, acting through the United States Agency for International Development ("USAID") for More Participatory, Effective and Accountable Governance, dated as of September 28, 2013.

WHEREAS, on September 28, 2013, the Grantee and USAID entered into the Development Objective Cooperation Agreement (the "Agreement") to support more participatory, effective and accountable governance as described in Annex 1 (the "Amplified Description") to the Agreement; and

WHEREAS, the Grantee and USAID desire to amend the Agreement in order to:

- 1) increase the total amount obligated by USAID from \$21,181,128.00 to \$26,528,193.00, thus providing additional funding of \$5,347,065.00; and
- 2) increase the Grantee's host country contribution from \$3,056,667 to \$3,538,593.

NOW, THEREFORE, the Parties hereby agree that the Agreement shall be amended as follows:

1. Section 3.1 (a) of the Agreement entitled "USAID Contribution" is deleted in its entirety and the following is substituted therefore:

"(a) The Grant. To help achieve the Objective set forth in this Agreement, USAID, pursuant to the Foreign Assistance Act of 1961, as amended, hereby grants to the Grantee under the terms of the Agreement an amount not to exceed twenty-six million, five hundred and twenty-eight thousand, one hundred and ninety-three United States ("U.S.") Dollars (\$26,528,193.00) (the "Grant")."

2. Section 3.2 (b) of the Agreement entitled "Grantee Contribution" is deleted in its entirety and the following is substituted therefore:

“(b) The Grantee’s contribution, based on USAID’s contribution in Section 3.1(a), will not be less than the equivalent of three million, five hundred and thirty-eight thousand, five hundred and ninety-three (\$3,538,593) U.S. dollars, composed of in-kind or cash contributions from current budgetary resources. If USAID changes the amount of the Grant in Section 3.1(a) incrementally, as contemplated herein, the Grantee’s contribution shall change with each increment accordingly, such that the Grantee’s contribution will not be less than the equivalent of one-third of that portion of the Grant that is used to support activities that either directly provides substantial benefit to the Government of Armenia or involves the direct and substantial involvement of the Government of Armenia in the administration, control or management of such assistance. The precise amount of Grantee contribution shall be indicated in USAID’s written notice of each incremental contribution. In the event that USAID decreases the grant amount in Article 3.1(a) under the authority of Article 3.1(c), the Grantee contribution shall be correspondingly decreased in accordance with the calculation provided herein, and such decreases recorded by USAID implementation letter. The Grantee’s total estimated planned contribution to the Objective will be subject to availability of budgeted funds to the Grantee for this purpose and to USAID providing the total estimated amount in Section 3.1(b). The Grantee will report at least annually in a format to be agreed upon with USAID on its cash and in-kind contributions.”


