This is to certify that the goods from Dean & Pattisen (20600 Pieces of Disposable Medical Clothing and 25000 Isolation Gowns) have arrived at the CGO airport on the 20th of April 2020. However, due to not having the permission for Landing for the 22nd of April flight the shipping forwarder/broker didn't take risk to check in the goods into the airport Terminal. This could have been a big risk, since the permission for the landing was only provided at 20:27 China local time on the 21st of April. It is needed at least 28 Hours to check in and inspect the goods prior to departure, since our cargo was too high, it would have been impossible to catch the flight at that time and the flight would have left the CGO airport without any cargo on it.

22 April 2020 from Zhengzhou International Airport (CGO) (Permission Number: CAD/N455)

On the next week the government of China imposed new regulation for export, and meantime we had to move all the cargo to another port XIY which put us in the situation where we had to transfer cargo to XIY, change QC stickers and packaging for 45600 PCs of protective products. Each packaging was changed and adapted to the new rules and regulations. When we changed the Quality Stickers and Packaging, another regulation was implemented by the Chinese Government. The government requested Category A medical test report/Certificate for 25000 units of Isolation suites. However, since the 2014 health reform in China, Category A certificate is not being issued by the government and only Category B was being used. We have still managed to check in and ship the 20600 units of Disposable medical clothing on the 28th of April, but we were not able to ship 25000 Isolation Suites at that time. Right after that we had to apply to the local government in Hangzhou and asked the local officials to help to solve this issue. We hereby confirm that the process is moving forward and the remaining goods will ship as soon as the sufficient documents matches export regulations within this week 11 May 2020 to 17 May 2020. W
