## 3rd Partners' meeting on the "Better Labs for Better Health" initiative: Improving the quality of laboratory services in the WHO European Region Almaty, Kazakhstan 9-10 October 2018

I have the honour to inform you that the World Health Organization Regional Office for Europe is organizing a 3rd Partners' meeting on the "Better Labs for Better Health" initiative: Improving the quality of laboratory services in the WHO European Region to be held on 9-10 October 2018 in Almaty, Kazakhstan.

The main objectives of this meeting will be to:

- Disseminate to a wide audience the progress of the Better Labs for Better Health initiative from 2016 to the present and inform on current activities;
- Show progress in national reforms of laboratory systems, national capacity building in the area of laboratory quality and safety and discuss priorities for the establishment of laboratory networks for preparedness and response,;
- Discuss the role of laboratory quality management systems in AMR surveillance;
- Provide a forum for countries to work together to strengthen their laboratory services by sharing expertise, experience and lessons learned including an open discussion on how to enhance countries' involvement and ownership of laboratory reforms.

An outline of the scope and purpose of the meeting is attached.

I have pleasure in inviting you to nominate two participants for this meeting. One participant who is playing a pivotal role in optimizing the diagnostic and public health laboratory system in your country and who is a member of a national laboratory unit or national laboratory working group should it be present in your country; and ideally another participant who is an expert in the field of antimicrobial resistance. Key discussions of the meeting will focus on laboratory systems reform, advocacy and partnership, building capacities through mentorship and external quality assessment needs in the region.

The working languages will be English and Russian and simultaneous interpretation will be provided.
