Congratulations on your match with us, and welcome to Lincoln Medical Center Internal Medicine residency program. Your contract dates are from July 1, 2020 to June 30, 2021, contingent on your compliance with our institutional policies governing postgraduate trainee appointment process.

You will join the program as a Program Level (PL) 1 resident. Your CIR/SEIU house salary is \$66,247 as a PGY 1 based on your years of accredited post-graduate experience.

As an indication of your acceptance of this position, please sign this letter and return it immediately to this office. If a signed copy of the letter is not received within 30 days of receipt, our offer may be withdrawn. By accepting this position, you agree to the roles and responsibilities of a medical resident. You will be evaluated at the end of each rotation, semi-annually and at the end of your training year in accordance with the ACGME six core competencies. Please note, it is an institutional policy that you must successfully pass the USMLE Step 3 prior to promotion to the PL-3 year of the training program. If you do not successfully pass the exam by November 15 of your PL-2 year you will receive a non-renewal of contract for the next academic year.

Enclosed you will find your employment package and schedule. Please complete all documents prior to arrival and pay specific attention to the instructions and deadlines.

Please call the Employee Health Department at (718) 579-5648 to schedule your health clearance appointment; the Human Resources department at 718-579-5257 to schedule your employment clearance appointment and (718) 579- 5874 or (718) 579-4739 to schedule your credential clearance appointment as soon as possible. It is required that you complete all three (3) clearance appointment before June 12, 2020, to allow sufficient time to complete credentialing and employment clearance before July 1, 2020.

Please bring the following original documentation for verification: Medical School diploma, documentation of previous training if applicable, USMLE score reports and Employment eligibility verification as outlined on page 9 of the USCIS Form I-9. If you are a recent graduate your final transcript was not uploaded in ERAS. Therefore, please request that your medical school send your official final transcript via Email to [Linmed@Linmed.or](mailto:Linmed@Linmed.or) or they can mail a hard copy to:


