Consultation of data for Sustainable Development Goal 6 global progress reports on drinking-water, sanitation and hygiene

The World Health Organization (WHO) and the United Nations Children's Fund (UNICEF), through the Joint Monitoring Programme for Water Supply, Sanitation and Hygiene (JMP), are custodian agencies to monitor global progress of implementation of the Sustainable Development Goal (SDG) targets 6.1 and 6.2 for provision of drinking-water, sanitation and hygiene services for all. Within the SDG framework, universal access to water, sanitation and hygiene (WASH) for all entails the provision of services at home and in other key settings, including schools and health care facilities.

JMP published global reports on SDG baselines for WASH in schools (2018) and WASH in health care facilities (2019), and is currently in the process of updating the data with the aim of publishing the next edition of progress reports. JMP prepared country estimates that are based on previous data consultations and publicly available national data sources.

Herewith we kindly request you to facilitate a data consultation process by involving the responsible ministries and authorities, including the national statistical office and the ministry of education as appropriate. We specifically request your support in the following:

- 1. Review the draft estimate on WASH in schools and associated data sources that are presented in the enclosed country file, and provide any additional information that can be used in updating the country estimate; and
- 2. Review the draft estimate on WASH in health care facilities and associated data sources that are presented in the enclosed country file, and provide any additional information that can be used in updating the country estimate
