The first *Strategy and action plan for refugee and migrant health in the WHO European Region* was adopted by the 66th session of the WHO Regional Committee for Europe on 13 September 2016. The Strategy and Action Plan has since been a guide in promoting actions to improve the health of refugees and migrants not only in the WHO European Region but also in other WHO regions.
