

ADDENDUM

TO THE QUESTIONNAIRE FROM THE WORLD HEALTH ORGANIZATION ("WHO") TO FOLLOW UP ON THE IMPLEMENTATION OF THE STRATEGY AND ACTION PLAN FOR REFUGEE AND MIGRANT HEALTH IN THE WHO EUROPEAN REGION

This Addendum is intended to supplement the WHO Questionnaire to follow up on the implementation of the Strategy and Action Plan for Refugees and Migrant Health in the WHO European Region (the "Questionnaire") sent to the Ministry of Internally Displaced Persons from the Occupied Territories, Labour, Health and Social Affairs Georgia on 17 December 2019, which the Ministry of Internally Displaced Persons from the Occupied Territories, Labour, Health and Social Affairs Georgia has returned to WHO on 14 January 2020. This Addendum becomes an integral part of the WHO Questionnaire.

PRIVACY AND PERSONAL DATA PROTECTION

I. Data are the basis for all sound public health actions and the benefits of data-sharing are widely recognized, including scientific and public health benefits. Whenever possible, WHO wishes to promote the sharing of health data, including but not restricted to surveillance and epidemiological data.

As used herein, the term "Data provider" means a duly authorized representative of the governmental body with authority to release health data of the country to WHO (i.e. the Ministry of Health or other responsible governmental authority). The recipient of this Questionnaire is responsible for ensuring that he/she is the Data provider, or for providing this Questionnaire to the Data provider.

In this connection, and without prejudice to information sharing and publication pursuant to legally binding instruments, (such as the International Health Regulations (2005)) by providing data to WHO, the Data provider:

- confirms that all data to be supplied to WHO hereunder have been collected in accordance with applicable national laws, including data protection laws aimed at protecting the confidentiality of identifiable persons;
- agrees that WHO shall be entitled, subject always to measures to ensure the ethical and secure use of the data, and subject always to an appropriate acknowledgement of the country:
 - i. to publish the data, stripped of any personal identifiers (such data without personal identifiers being hereinafter referred to as "the Data") and make the Data available to any interested party on request (to the extent they have not, or not yet, been published by WHO) on terms that allow non-commercial, not-for-profit use of the Data for public health purposes (provided always that publication of the Data shall remain under the control of WHO);
 - ii. to use, compile, aggregate, evaluate and analyse the Data and publish and disseminate the results thereof in conjunction with WHO's work and in accordance with the Organization's policies and practices.

The Data Provider may in respect of certain data opt out of (or any part of) the above, by notifying WHO thereof in writing at the following address, provided that any such notification shall clearly identify the data in question and clearly indicate the scope of the opt-out (in reference to the above), and provided that specific reasons shall be given for the opt-out.
