With this letter I would like to address you regarding procurement of the goods within the frames of Georgia COVID-19 Emergency Response Project. Considering the global shortage of the COVID-19 supplies, we put every effort in identifying and securing the emergency items. Following our engagement with the market, we have identified few suppliers that stand ready to provide priority items to the Ministry of Internally Displaced persons from the occupied Territories, Labour, Health and Social Affairs of Georgia with reasonable timeframe and competitive price.

Please find enclosed quotations for the following items, as well as price adequacy analysis:

1. Critical Care Ventilators;
2. Portable Ventilators;
3. COVID-19 Diagnostic Kits.

The offer is valid for very limited time.

In the light above, we would like to kindly request the World Bank's No Objection to proceed with direct contracting to the following suppliers:

1. LLC MTECH - 30 units of Critical Care Ventilators – USD 13,500 each – To be delivered in early June – total contract amount USD 405,000;
2. MDS LTD – 15 units of Portable Ventilators – approx. USD 15,500 each – 5 units to be delivered in June and 10 units – in July. Total contract amount USD 235,028;
3. LLC Green Lab – 30,000 units of COVID-19 Rapid tests – USD 5.2 each – To be delivered in May – total contract amount USD 156,000.
