Section 0: Executive summary

The overall objective of the EU Twinning Project "Strengthening Blood Safety System in Georgia" is to support public health policies and programmes to prevent the spread of communicable diseases, through promoting the safety of substance of human origin and ensuring the highest possible quality level of blood transfusion service in Georgia.

The specific objectives of the Project are to upgrade national blood safety legislation in accordance with European regulations and strengthening national institutional capacities in Georgia with the aim to provide equal safety standards of blood components across the nation, assure safety of blood related services and prevent the spread of blood borne infections by blood transfusion.

The project consists of four components as follows:

- Component 1 : Approximation of Georgian primary and secondary legislation with the Union acquis on blood safety performed
- Component 2: A well-organized, nationally coordinated blood transfusion system established and functioning in accordance with the provisions of the Association Agreement
- Component 3: Blood transfusion services based on voluntary blood donation are able to ensure safe, adequate and sustainable blood supplies.
- Component 4 : Capacity of relevant state authorities and other key stakeholders strengthened to ensure safety and quality of blood transfusion service.

The Resident Twinning Advisor (RTA) Mr. Algirdas Griskevicius moved to Georgia and started working on the project on January 15, 2020, making that date the starting date of the implementation period of the EU Twinning Project "Strengthening Blood Safety System in Georgia".

As the Beneficiary Administration, the National Center for Disease Control and Public Health (NCDC&PH) of the Ministry of Internally Displaced Persons from the Occupied Territories, Labour, Health and Social Affairs of Georgia equipped the RTA office (RTA and RTA assistants) with 2 office rooms, 5 computers, internet and telephone connections, office supplies and ancillaries.

After the arrival of the RTA, Initial Work Plan (IWP) was drafted; the IWP Preparation Meeting was held on 28 March, 2019, and the Communication and Visibility Plan was developed.

The RTA assistants were selected through an official recruitment and selection procedure in February and March 2020. RTA Assistant and RTA Language Assistant started working on 25th of March.

The initial Project Steering Committee meeting (PSCM, so-called "zero Project Steering Committee meeting") was organized on 9 March 2020, during which the activities foreseen for the first six months were presented and the IWP and the Communication and Visibility Plan were adopted.

Georgia confirmed its first COVID-19 case on February 26. To halt further spread of the virus, on March 14 the Government of Georgia announced about the decision to suspend land travel with neighboring countries.

On March 21, the President of Georgia issued Edict No 1 and declared the State of Emergency through the whole territory of Georgia until April 21. The GoG suspended all air movement and banned all foreign national from entering the country until at least May 10.

As a result of registered cases of internal disease transmission, Georgia announced nationwide lockdown and partial curfew starting from March 31. The new restrictions included observance of curfew between 21:00-06:00, suspension of public transportation, limiting the number of passengers in a single vehicle and banning of gathering of more than three people and observance a 2-meter distance.

To slow the spread of Coronavirus, by the decision of the Georgian Government, the state of emergency was extended until May 22, entailing a night curfew, suspension of public transport and a ban of gathering of more than three people.

The above restrictions, to some extent, affected the project implementation process and to ensure uninterrupted progress of the project, before the restrictions are gradually lifted, those activities have been planned that could be implemented remotely.

During the reporting period, Side Letter no.1 was drafted, signed and submitted, without reallocating resources.

The following decisions need to be taken at the upcoming PSCM1 in June 2020:

- Adoption of the PSCM1 agenda;
- Adoption of the minutes from the initial PSCM;
- Adoption of IQR1;
- Adoption of the rolling work plan for project implementation, months 6-9 (Q2 and Q3);
- Translation of guides and recommendations /WHO Interim Guide, ABPN Rapid Brief Paper, AABB Outbreak Planning Checklist, AATM Recommendations, US/FDA Information, ECDC Technical Report/ related to the activities of blood facilities during Coronavirus pandemic.
- Any other business.

Policy and Sector Developments

To improve quality and safety of blood and blood components, a number of activities are ongoing in the country, in particular:

- Testing of donor blood for transfusion transmissible infections (TTI), such as hepatitis B and C, HIV, and syphilis, is performed on 100% of blood donations within the framework of the State Safe Blood Program.
- With support of the Global Fund, two nucleic acid testing (ID-NAT) systems were purchased (Procleix Panther System, Grifols), which will substantially improve the safety of blood components by reducing the "Window Period" for TTI detection.
- All blood banks enrolled in the state program participate in professional testing (PT) schemes which are implemented under agreements signed with reference laboratories with international accreditations (ESfEQA, RADNDOX/RIQAS). In addition, from December 2019, an external quality control pilot program was launched at the Lugar Center, which implies that blood banks will conduct control tests of professional panels prepared by the Lugar Center.
 - By the end of 2019, a NAT laboratory has been put into operation at the Lugar Center.
- Since January 2020, a pilot of nucleic acid testing (NAT) of blood donations has been introduced at Lugar Center with current enrolment of 10 blood banks operating in Tbilisi. Countrywide scaling up of the pilot is planned by the end of 2020.
- An active communication campaign is underway to popularize non-remunerated, voluntary blood donorship.

The main policy changes are related to the draft law on quality and safety of blood and blood component, which will form the regulatory framework on blood safety for the blood transfusion service. The RTA-C must report whether working groups have been set up in relation to the project tasks. In addition, the RTA-C should facilitate the organization of telework with these working groups and stakeholders during the Coronavirus quarantine period.

Project Assumptions

- Full openness and support from the NCDC&PH have been given to the project in Q1 of its implementation.
- Adequate working conditions have been provided to the RTA upon his arrival.
- The cooperation between the Twinning partners is at a high professional level, with both partners demonstrating mutual respect and understanding.
- The state of achievements is affected by the current coronavirus situation.
- Both sides have anticipated activities, which can be taken or started remotely.
