Issues discussed:

- 1. **Incoterms** The edition of Incoterms that shall apply is DDP Incoterm 2020.
- 2. **Payment Terms** The method and conditions of payment to be made to the Supplier under this Contract shall be as follows: Payment shall be made in GEL to the following manner:

Advanced payment - forty (40%) percent of the Contract Price shall be paid, within ten (10) days of signing of the Contract and upon submission of a claim for the amount enclosed with demand guarantee;

On acceptance:

Payment shall be made partially, upon delivery of the batches, within 15 days, against invoice and delivery acceptance certificate.

Forty (40%) percent of advance payment will be recovered from the final payment.

- 3. **Final Destination** The Purchaser will provide the supplier with 100 locations of the final destination of the goods within two weeks from the contract signature.
- 4. **The inspections and tests** The Purchaser and Consignee shall conduct inspections and tests jointly within two calendar days following the notification from the Supplier at the place agreed in advance between the parties. After inspection conducted, the supplier is obliged to ensure delivery of the goods to the final destination specified by the Purchaser within three calendar days.
- 5. **Warranty** the parties agree that the warranty shall remain valid as it is specified in the price schedule N1. This Minute of the Contract Negotiations represents an integral part of the Contract COVID19/G/DC-23.
- 6. **Related services** Due to the pandemic situation, online training for medical devices will be conducted by the supplier.
