
Our code of ethics demands a total commitment to the health-care needs of patients - a key driver of progress and development.

THE H4D CONSULT STATION®: A UNIQUE AND INNOVATIVE HEALTH-CARE TOOL

The Consult Station® is H4D's telemedicine booth, combining professional measurement instruments, high-definition screens, and a state-of-the-art communications system. It allows reliable and reproducible health data to be collected and shared. **The Consult Station® is a patented and certified Class II Medical Device (meeting the requirements of European Directive 93/42/EEC), and the Food and Drug Administration FDA has also cleared it to be marketed in the United States.**

This device offers two operating modes: teleconsultation and telemonitoring.




In teleconsultation mode (TK), the booth, coupled with the Consult Access medical software package, allows the physician to conduct general or specialized medical consultations remotely. The physician guides the patient via videoconferencing, measuring vital signs and performing any medical examinations they deem necessary. The teleconsultation mode is used for general primary-care consultations, and to support post-treatment monitoring. It also supports secondary and tertiary preventive health-care visits.

In telemonitoring mode (TS), the Consult Station® is used to perform health check-ups. The user sits in the booth and follows instructions displayed on the screen, while a highly intuitive video tutorial guides and assists him in measuring his vital signs or carrying out tests. The telemonitoring mode is used to support primary prevention and screening, along with post-treatment monitoring- in particular for chronic conditions.




Consult Stations® can be deployed in a variety of environments, including workplaces, local communities, hospitals, retirement and nursing homes, student residence halls, universities, etc.



The Consult Station is a fully regulated medical device bearing the EC mark of approval. Minimum age for users: 14 years, if accompanied by a legal representative. Read the instructions carefully before use!


MYCONSULTSTATION.COM : A SECURE WEBSITE FOR PATIENTS AND DOCTORS

After a session in the Consult Station®, whether the visit was for a health check-up or a medical consultation, patients can access all their data in a secure platform requiring a username and password. Our website, www.myconsultstation.com, enables patients to view their full visit history, along with their vital signs. A patient can also transmit this data to her doctor for analysis.
