DEAR MS DEPUTY MINISTER.

I have the pleasure of congratulating you on your appointment as Deputy Minister of the Internally Displaced Persons from the Occupied Territories, Labour, Health and Social Affairs of Georgia. I would like to express my belief for the further successful development of our mutually beneficial cooperation and I sincerely hope for your willingness to work together for strengthening and deepening our bilateral relations in areas of mutual interest.

Having in mind that, I would like to confirm the willingness of the Republic of Bulgaria to sign a bilateral agreement on the regulation of labour migration between the Republic of Bulgaria and Georgia.
